## Prima Uña de Gato II Cat's Claw 3% Alkaloids

**Prima Uña de Gato II** (capsules #55041 and liquid #55081) replaces Prima Uña de Gato (#55040 and #55080). This replacement formula utilizes a high quality whole bark extract of cat's claw, to insure it offers the synergy of all the constituents in cat's claw. It also has a minimum of 3% total alkaloids. We no longer label it 'TOA-free', because we could find no corroborating evidence in the research literature for the actual use of cat's claw, that tetracyclic alkaloids (TOAs) have any significant effect on pentacyclic alkaloids (POAs).

The essential formulations have not changed. Like our original Prima Uña de Gato, **Prima Uña de Gato II Capsules** contain the minerals magnesium, manganese, and chromium, as well as enzymes. **Prima Uña de Gato II Liquid** contains no enzymes, and a serving contains minerals at these typical levels: Magnesium 2.0 mg, Potassium 0.42 mg, Sodium 0.28 mg, and Boron 2.2 µg.

Cat's claw (Uncaria tomentosa) is a woody vine that has long been used by indigenous healers in the rainforests of the Peruvian Andes and elsewhere in South America and Central America.\* Its use dates back to the 1500s and the ancient Incan Empire. Asháninka priests in Peru reputedly considered cat's claw to have great powers and life-giving properties.\*

In recent times cat's claw has been studied for its ability to support gastrointestinal and immune functions.<sup>\*</sup> Research suggests that in the gastrointestinal tract it can support healthy microbial balance and soothe irritated tissue.<sup>\*</sup> Cat's claw has antioxidant properties, and it may support circulation by strengthening capillaries.<sup>\*</sup> Active constituents include pteropodine, isopteropodine, rhynchophylline, mitraphylline, hirsutine, and quinovic acid glycosides.
